- 3<sup>rd</sup> St and Hawthorne Ave and Option 1B
- Greenwood Ave and 4<sup>th</sup> St Option 2
- 3<sup>rd</sup> Street and Roosevelt Ave Option 2
- 27<sup>th</sup> St and Connors Ave Option 1 with changes
- Purcell Blvd and Neff Rd Option 1 with changes
- Greenwood Ave and 3<sup>rd</sup> St Option 2

Assigned Action Items: RLL to post updated 4/30/2015 minutes on webpage.

Alta will develop a recommendation for a Downtown bike parking application process and approval criteria for the City to consider. Criteria will include a barrier-free zone and supporting a pedestrian-oriented environment.

RLL to provide code updates, and verify roadway measurements if necessary for preferred alternatives. Final concept report will detail how options were selected.
